NOTICE TO THE MARKET

Rio de Janeiro, August 23, 2011 - Equatorial Energia S.A. (BM&FBOVESPA: EQTL3) and CEMAR – Companhia Energética do Maranhão informs the market that today ANEEL – Agência Nacional de Energia Elétrica (Brazilian Electric Energy Regulatory Agency) approved the annual tariff adjustment for CEMAR.

Considering the net effect of the financial components' inclusion in the rate, the average effect to be perceived by the consumer will be 7.25%. Within the financial components, the main items considered were R\$91.8 million in Low Income Subsidy and R\$15.8 million of the Light for All Program (PLPT).
